Senate Bill 656

Ways and Means

Baltimore County Board of Education - Alterations of Elected Member Districts and Establishment of Redistricting Process

This bill requires that, beginning with the 2034 general election, the members of the Baltimore County Board of Education currently elected from each of the seven councilmanic districts in the county must instead be elected from each of seven school board districts established through a specified redistricting process. **The bill takes effect July 1, 2025.**

Fiscal Summary

State Effect: The bill does not directly affect State finances.

Local Effect: Any costs associated with the redistricting process under the bill are assumed to be absorbed within existing resources.

Small Business Effect: None.

Analysis

Bill Summary: Beginning after the 2030 U.S. Census, the school board districts from which members of the Baltimore County Board of Education are elected must be reapportioned after each decennial census and be effective for each general election where a member will be elected until the following decennial census. The reapportioned school board districts must be substantially equal in population.

By December 1 of the calendar year immediately following each decennial census, the Baltimore County Board of Education must submit a proposal to the Baltimore County Delegation to the General Assembly on reapportioning the school board districts. The delegation must consider the proposal and introduce legislation to reapportion the school board districts in the session immediately following the date that the proposal was submitted. The legislation may differ from the proposal submitted by the board.

Current Law: The Baltimore County Board of Education consists of seven nonpartisan members elected from each of the seven councilmanic districts in the county, four members appointed by the Governor from the county at large, and one student member. The elected and appointed members serve a term of four years. The elected members are elected in gubernatorial election years and the appointed members are appointed by the Governor in presidential election years.

The Baltimore County Board of Education is 1 of 4 hybrid school boards in the State with both appointed and elected members. There are 20 elected school boards in the State. The **Appendix – Local Boards of Education Membership** shows the selection methods, terms of office, and membership of the 24 local boards of education.

Appendix – Local Boards of Education Membership

The composition of the local boards of education varies with members serving three- to four-year terms. Twenty counties have elected school boards and four counties have combined appointed and elected school boards. Twenty-two boards have student members; however, only 8 boards allow student members to vote, which generally excludes authority to vote on matters relating to collective bargaining and personnel. Three counties with voting student members also preclude student members from voting on matters relating to operating and capital budgets. **Exhibit 1** shows the selection methods, terms of office, and membership of the 24 local school boards.
