Ladies and Gentlemen:

On May 16, 2025, the Honorable Wes Moore, Governor, vetoed the following pieces of legislation passed by the General Assembly; the reasons for the vetoes are indicated:

SB 980 Senators Corderman and M. Jackson

Policy

NATURAL RESOURCES – MARYLAND HERITAGE AREAS AUTHORITY - FUNDING AND GRANTS

Authorizing the Maryland Heritage Areas Authority to award grants and loans to certain entities for the management of certified heritage areas under certain circumstances; establishing a maximum funding amount of \$300,000 for certain grants, not to exceed 80% of the estimated project cost; decreasing from 10% to 7%, or \$600,000, whichever amount is greater, the percentage of Program Open Space funds transferred to the Maryland Heritage Areas Authority Financing Fund that may be used for certain operating expenses; etc. **EFFECTIVE JULY 1. 2025**

PROCUREMENT - STATE DEPARTMENT OF EDUCATION -LOCAL FOOD PURCHASING PROGRAM

Requiring the State Department of Education, in coordination with the Department of General Services and the Department of Agriculture, to establish a program to procure local food for local school systems from certified local farms and certified Chesapeake invasive species providers under certain circumstances; altering a certain percentage price preference adopted by the Board of Public Works by regulations; requiring the Board to adopt certain regulations relating to limiting responses for certain procurements; etc.

Authorizing the Director of the State Lottery and Gaming Control Agency to issue certain fraternal organizations a license for not more than three instant ticket lottery machines; altering the distribution of proceeds from instant ticket lottery machine sales by veterans' organizations; providing for the distribution of proceeds from instant ticket lottery machine sales by fraternal organizations; altering certain requirements concerning the conduct of gaming through instant ticket lottery machines; etc. EFFECTIVE JULY 1, 2025
